THE PCYC ARTS & TECH HIGH SCHOOL, A CONTRACT ALTERNATIVE PROGRAM WITH MINNEAPOLIS PUBLIC SCHOOLS, PROVIDES A DIPLOMA-BASED HIGH SCHOOL EDUCATION FOR OVER 270 STUDENTS YEARLY ON THE PCYC CAMPUS IN NORTH MINNEAPOLIS AT OLIVER & WEST BROADWAY. IN OPERATION SINCE THE EARLY 1970S, THE SCHOOL INFUSES ARTS AND TECHNOLOGY INTO THE CORE CURRICULUM AS A STRATEGY TO ENHANCE ACADEMIC PERFORMANCE AND TEACH LIFE-LONG LEARNING SKILLS. THE CAPRI THEATER 'WENT DARK' AT THE END OF MAY 2019 TO COMPLETE CONSTRUCTION ON AN EXTENSIVE RENOVATION AND EXPANSION PROJECT. AN OFFICIAL GROUND BREAKING CEREMONY WAS HELD ON OCTOBER 17, 2019.
