WE SERVED JUST OVER 160 UNIQUE STUDENTS DURING THE 2023-2024 SCHOOL YEAR OF WHICH 86% WERE JUNIORS OR SENIORS. 100% OF GRAD-ELIGIBLE SENIORS RECEIVED THEIR DIPLOMAS. OUR STUDENT BODY WAS COMPRISED OF 98% STUDENTS OF COLOR AND 95% QUALIFIED FOR EDUCATIONAL BENEFITS (FREE OR REDUCED LUNCH). AS WELL MORE THAN 25% MET THE FEDERAL GOVERNMENT'S DEFINITION OF HOMELESS AND HIGHLY MOBILE. THIS YEAR WE HAVE SEEN A SHARP DECLINE IN FIGHTS AND SUSPENSIONS OVERALL.
